

## Registration: Go Short Campus 2026

### 1. General requirements for participation

> An applicant is eligible for participation in the Go Short Campus if:

- They have completed at least two short films;
- They are from (geographical) Europe;<sup>1</sup>
- They are available to attend the campus program in Nijmegen, the Netherlands from Wednesday April 8<sup>th</sup> until Saturday April 11<sup>th</sup>.

If you don't fit into these criteria, but are interested in joining the program, please contact us. We evaluate this case by case.

> The participation fee is €370,-

The participation fee includes access to workshops and masterclasses in the campus program, one-on-one meetings, accommodation, access to all screenings and festival events, breakfast, lunch, dinner, and VAT (9%).

### 2. Selection process

> Requested materials for entry:

The application deadline for the Go Short Campus is before or on Sunday, February 15<sup>th</sup>, 2026. The registration for the campus is only complete when participants have filled out the registration form and emailed the attachments to [industry@goshort.nl](mailto:industry@goshort.nl).

The following information is submitted via the registration form:

- Name, name of company (if applicable), email address, phone number and address;
- Short bio and links to previous works;
- Ambition for participation: what are you looking for, what goals do you wish to achieve? Are you, for example, seeking financing, co-producers, contact with programmers or filmmakers, or something else?

> In case the participant is selected, Go Short will notify the participant as soon as possible, but ultimately on Monday March 2nd, 2026.

The participant will, if they are selected, receive an official invitation and an invoice upon selection. The participant will need to accept the invitation by replying to this email within one week after receiving it.

Participation in the campus program will only be made final once the participant has paid the participation fee. The participation fee is due to be paid within 14 days after reception of the invoice. Only after reception of the payment, the participant can participate in the Go Short Producers Campus.

> In case of cancelling by the participant after accepting the invitation we apply the following rules:

- a) cancellation before March 13th, 2026: a refund of 50% of the participation fee;
- b) cancellation after March 13th, 2026: no refund.

### **3. Travel and insurance**

- > The costs of transport of all participants are the responsibility of the participant.
- > Participants are not covered by the festival insurance. Any damage done by the participant is for their own responsibility and insurance.

### **4. Conclusion and contact**

> Participation in the Go Short Producers Campus implies acceptance of these regulations and decisions made by the management and board. The management and/or board of the Go Short foundation decide in all cases where the regulations do not suffice.
