

Go Short Campus Regulations 2019

1 General requirements for participation

1.1

An applicant is eligible for participation in the Go Short Campus if:

- He/she has finished a European film school within the last 2 years or is studying at a European film school;
- He/she is from (geographical) Europe.[1]

** If you don't fit into these criteria, but are interested in joining the program, please contact us, we evaluate this case by case.*

1.2

Application deadline for the Go Short Campus:

- Before or on Sunday 20 January 2019

1.3

Participation fee:

- €295,- (included in the price: workshops, masterclasses, accommodation (youth hostel), access to all screenings and festival events, breakfast, lunch, VAT)

1.4

Requested materials for entry:

- A completed online entry form, including motivation, goals to be achieved and links to previous films
- Photo from participant
- CV
- Project description / concept and description of the stage the project is currently in

2 Selection

2.1

In case the participant is selected, Go Short will notify the participant as soon as possible, but ultimately on Friday 15. February 2019.

2.2

In order to introduce the participants to the professional guests attending the festival, Go Short gives participants an opportunity to represent themselves by a previous film in the video library. Go Short requires the catalogue credits and film stills for each film no later than 22 February 2019. Go Short accepts no liability in the event that its publications reproduce inaccuracies in submitted materials. Catalogue writings are entirely at the discretion of the festival.

2.3

The participant will, in case he or she is selected, receive an official invitation and an invoice upon selection. The participant will need to accept the invitation, by replying this email **within one week** after receiving. Participation in the campus program will only be made final once the participant has paid the participation fee. The participation fee is due to be paid within 14 days after reception of the invoice. Only after reception of the payment the participant may participate in the Go Short Campus.

2.4

In case of cancelling by the participant after accepting the invitation we apply the following rules:

- a) cancellation before 10. March 2019: a refund of 50% of the participation fee;
- b) cancellation after 10. March 2019: no refund

3 Travel and insurance

3.1

The costs of transport of all participants are the responsibility of the participant.

3.2

Participants are not covered by the festival insurance. Any damage done by the participant is for his/her own responsibility and insurance.

4 Conclusion and contact

4.1

Participation in the Go Short Campus implies acceptance of these regulations and decisions made by the management and board. The management and/or board of the Go Short foundation decide in all cases where the regulations do not suffice.

4.2

The management and/or board of the festival can always decide on exceptions of the regulations.
